Dear Resident/Occupier,

Parking Consultation Digswell Park Road Car Park

Parking Services consulted the residents and car park users during July and August 2018 regarding the parking restrictions in Digswell Park Road car park. The existing restrictions allow limited waiting for 30 minutes no return within 30 minutes 9am -11am Monday to Friday; they were put in place to prevent commuters from using the car park.

Parking Services proposed to change the limited waiting period to 2 hours no return within 2 hours between 9am – 1pm Monday to Friday. One parking bay will be removed to keep the access to Hertford Road clear; this section of road is used as a crossing point by pedestrians. See the attached plan. 46 letters were sent to the addresses nearest the car park and cars were leafleted inside the car park. 17 responses were received. 16 responders voted in favour of the proposed changes. One responder did not specify a preference.

Parking Services is creating a draft legal document. A public notice of proposal will be advertised in the Welwyn Hatfield Times on Wednesday 5th December. Notices will also be erected in the car park. If you wish to object to the proposal please write to the Council using the contact details supplied in the public notice before the 27th December.

All objections received will be considered by the Cabinet Housing and Planning Panel at 7:30pm on Thursday 7th February in the Council Offices, The Campus, Welwyn Garden City, AL8 6AE. The meeting will be held in the Council Chamber on the ground floor

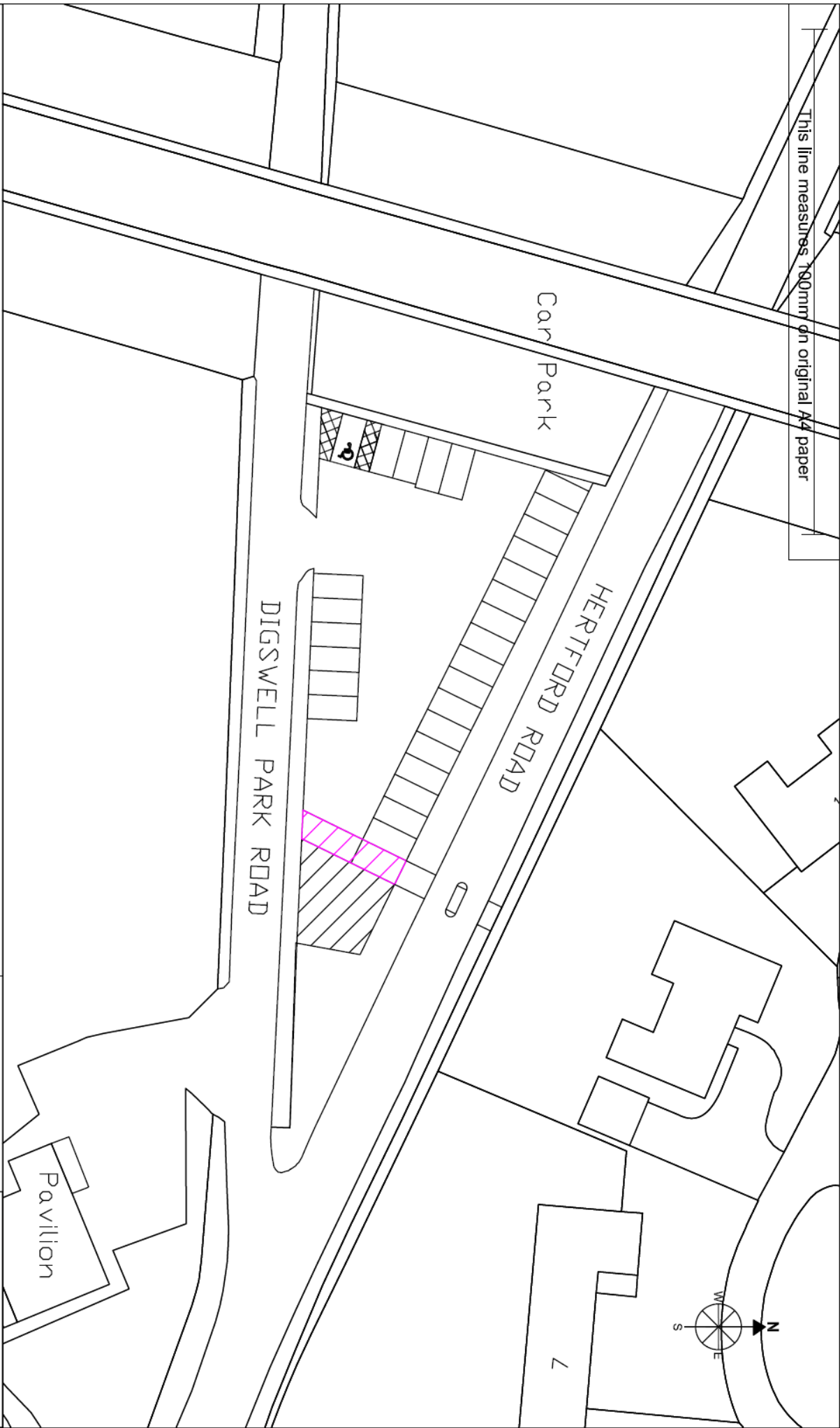
